*****WE ARE IN THE AREA OFF EDINGER ROAD ***

Please be aware that there is a parking fee at this site. \$3 on weekdays and \$5 on Sat & Sun. If you leave the site to get lunch and come back you will be charged again. Bring everything you need with you or you will pay to park every time you come in.

The gates are open by 7AM in the morning.

RV's are allowed in the park during the day, however if you do not fit in a single parking spot you will have to park in over flow parking. This lot is not terribly close to the field so please be aware of that.

There is some shade around the rings but a canopy might be a good idea to have along if needed.

MOVE-UPS

All pre-show move ups must be **received by 6pm, Monday, Feb 11, 2019**. The AKC requires move-ups to be in writing. You may send an email for a move-up to agilesam@gmail.com with your name, your dog's call name, the name & date of the trial and what class you want the dog to be moved to. If you miss the deadline for move-ups, you may move your dog up the first day of the show for any **subsequent** days even if you are not showing a dog that day. In addition a friend may do the move-up for you if you are not there. However you may not move up the day of the show for that day.

There will be day-to-day move-ups at the show provided the Trial Secretary receives them within 15 minutes after the end of the last class. There will be no move-ups in the morning before the start of the trial.

However, a dog which has been entered in a Novice "A" class for which it is not eligible to be entered in due to class restrictions on the dog or handler may be moved to the Novice "B" class under the following conditions: the request for the move must be in writing and presented to the Superintendent or Trial Secretary at least 30 minutes prior to the start of each trial. The request must state the reason and justification for the move from the Novice "A" class to the Novice "B" class.

DIRECTIONS TO MILE SQUARE PARK:

I- 405 SOUTH: Exit 15A- Warner Ave E. in about 2 miles, turn left onto Brookhurst Street to Edinger Ave. turn right - the entrance to the park will be on your right.

I- 405 NORTH: take Exit 12 for Euclid St/Newhope. Turn left onto Euclid N. go north past the park and turn left onto Edinger Ave. The entrance to the park will be on your left.

SET-UP & SECURITY:

NO SET UP BEFORE 3 PM on FRIDAY! There will be security on Fri & Sat night until **10 PM**. Leave things at your own risk.

MEASURING:

Our judge, Steve Larrison, is not a volunteer measuring official. He will be available to measure for this trial only before the Ex/Master Classes, before the Open Classes and before Novice Classes.
