### MOVE-UPS

---

All pre-show move ups must be received by **6pm, Monday, June 24, 2019**. The AKC requires move-ups to be in writing. You may

send an email for a move-up to [shelties259@gmail.com](mailto:shelties259@gmail.com) with your name, your dog's call name, the name & date of the trial and what class you want the dog to be moved to. If you miss the deadline for move-ups, you may move your dog up the first day of the show for any **subsequent** days even if you are not showing a dog that day. In addition, a friend may do the move-up for you if you are not there. However, you may not move up the day of the show for that day.

There will be day-to-day move-ups at the show provided the Trial Secretary receives them within 15 minutes after the end of the last class. There will be no move-ups in the morning before the start of the trial.

**However**, a dog which has been entered in a Novice "A" class for which it is not eligible to be entered in due to class restrictions on the dog or handler may be moved to the Novice "B" class under the following conditions: The request for the move must be in writing and presented to the superintendent or trial secretary at least 30 minutes prior to the start of each trial. The request must state the reason and justification for the move from the Novice "A" class to the Novice "B" class.

### DIRECTIONS to Allied Gardens Recreation Center, 5155 Greenbrier Ave., San Diego, CA 92120

---

Traveling on I-5 south:

Take the I-5 South to the 805 South. In approx. 11 miles, take the I-8 toward El Centro. Take Waring Road exit and turn left. Turn left onto Zion Ave and then right onto Glenroy St. The park will be at the end of Glenroy.

From I-15 Southbound:

Take the 15 South to the I-8 toward El Centro. Take Waring Road exit and turn left. Turn left onto Zion Ave and then right onto Glenroy St. The park will be at the end of Glenroy.

From I-8 Eastbound:

Take exit 9 onto Waring Rd. Turn left onto Zion Ave and then right onto Glenroy St. The park will be at the end of Glenroy.

### SET UP AND SECURITY:

Set up is Saturday morning! We will be unloading the trailer around 6 AM. This is a wide-open park! We will have a security guard until around midnight on Saturday, but not all night. Leave belongings at your own risk.
