### SET-UP/SECURITY

---

Set up is Monday after the rings are set. There is no security. Leave things at your own risk.

### MOVE-UPS

---

All pre-show move ups **must be received by 6 PM Tuesday October 15, 2019**. The AKC requires move-ups to be *in writing*. You may send an email for a move-up to [agilesam@gmail.com](mailto:agilesam@gmail.com) with your name, your dog's call name, the name and date of the trial and what class you want the dog to be moved to. If you miss the deadline for move-ups, you may move your dog up the first day of the show for any subsequent days even if you are not showing a dog that day. In addition, a friend may do the move-up for you if you are not there. However, you may not move up the day of the show for that day.

There will be day-to-day move-ups at the show provided the Trial Secretary receives them within 15 minutes after the end of the last class. There will be no move-ups in the morning before the start of the trial.

However, a dog which has been entered in a Novice "A" class for which it is not eligible to be entered in due to class restrictions on the dog or handler may be moved to the Novice "B" class under the following conditions: the request for the move must be in writing and presented to the Superintendent or Trial Secretary at least 30 minutes prior to the start of each trial. The request must state the reason and justification for the move from the Novice "A" class to the Novice "B" class.

**1 ½ miles from the Ontario Convention Center:**

**Going east on I-10**, Exit 55, take ramp right for Archibald Avenue North toward Ontario Airport. Bear left onto North Archibald Avenue. Turn right onto road.

**Going west on I-10**, exit 55B and take ramp right for Archibald Avenue North toward Ontario Airport. Turn right onto road.
