- 2. THIS SITE DOES NOT ALLOW TARPS AS GROUND COVERS & ALL MATS MUST BE TAKEN UP AT NIGHT. PLEASE TAKE UP YOUR MATS EVERY NIGHT FROM YOUR SET-UP AND SWITCH THE SPOT OF ALL CRATES EVERY NIGHT.**
- 3. SPRINKLERS MAY BE TURNED ON FRIDAY NIGHT – CHECK WITH THE TRIAL SECRETARY BEFORE LEAVING ON FRIDAY. IF THE SPRINKLERS ARE TURNED ON FRIDAY NIGHT, DO NOT LEAVE YOUR CANOPY COVER ON YOUR EZ-UP OVERNIGHT ON FRIDAY.**

MOVE-UPS

All pre-show move-ups must be received **by 6 PM, Monday, March 9**. The AKC requires move-ups to be in writing. You may send an email for a move-up to stephnishimoto@gmail.com with your name, your dog's call name, the name and date of the trial and what class you want the dog moved to. If you miss the deadline for move-ups, you may move your dog up on the first day of the show for any subsequent days even if you are not showing a dog that day. A friend may do the move-up for you if you are not there. You may NOT move up the day of the show for that day.

There will be day-to-day move-ups at the show, provided the Trial Secretary receives the move-up within 15 minutes after the end of the last class. There will be no move-ups in the morning before the start of the trial.

However, a dog which has been entered in a Novice "A" class for which it is not eligible to be entered in due to class restrictions on the dog or handler, may be moved to the Novice "B" class under the following conditions:

- The request for the move must be in writing and presented to the superintendent or Trial Secretary at least 30 minutes prior to the start of each trial.
- The request must state the reason and justification for the move from the Novice "A" to the Novice "B" class.

DIRECTIONS: Freedom Park EAST, 275 E. Pleasant Valley Road, Camarillo, CA 93010

From SOUTH - Take US HWY 101 North, exit Las Posas, turn LEFT onto S. Las Posas Road. Go 1 mile to Pleasant Valley Rd and turn RIGHT. Turn RIGHT on Eubanks and first left into parking lot. Parking Lot traffic is One Way.

From NORTH – Take US HWY 101 South, exit Las Posas, turn RIGHT onto S. Las Posas Road. Go 0.9 miles to Pleasant Valley Rd and turn RIGHT. Turn RIGHT on Eubanks and first left into parking lot. Parking Lot traffic is One Way.

SET-UP & SECURITY

Early set-up is on Thursday afternoon **AFTER 3:00 PM**. If you would like to help unload the trailer and set up the rings, please meet the course builders at noon. SPRINKLERS MAY BE TURNED ON FRIDAY NIGHT – CHECK WITH THE TRIAL SECRETARY BEFORE LEAVING. NO CANOPY COVERS ON YOUR EZ-UPS IF THE SPRINKLERS ARE TURNED ON. NO TARPS ALLOWED OVERNIGHT, ALL MATS MUST BE REMOVED AT NIGHT. This is a wide open park. There is no security guard -- leave things at your own risk.

MEASURING

The judges this weekend are NOT Volunteer Measuring Officials (VMO). They will be available to measure your dog(s) between classes for this weekend only (before T2B or FAST, before the Master/Excellent Classes, before Open and Novice Classes). If you need to be measured, you MUST be measured before your first run. If you need help getting measured, come by the scoring table and we will be happy to help you.

CHECK-IN AND RUNNING ORDER

START TIMES AND RUNNING ORDERS

Regular and Preferred will run concurrently in all Classes each day
All FAST classes will walk together, all levels will run in their jump height together
Open & Novice runs Small to Tall each day

FIRST DOG ON THE LINE AT 8:30 AM EACH DAY

You may arrive at any time before your run or follow the estimated guidelines below.
Please listen for any announcements about a change in the run order or walk-throughs. Dogs may be run in a different height or dog order from what is listed below when, in the opinion of the judge(s) and/or the Event Committee, such a change will result in a desirable and reasonable time savings. If necessary, walk-throughs may be added or combined if there are conflicts.
