Keeshond Club of Southern California Agility Trial

Friday, Saturday and Sunday, November 27, 28 and 29, 2020

Freedom Park EAST, Camarillo

Trial Hours 7:00 AM –4:00 PM

AGILITY GATE APP – Code 2468

This is an app for your iPhone or iPad and coming soon for Android. With this app you can go to a class and check-in, scratch, let the gate know you are FEO or that you have a conflict. When the class is running you can see who is running in the ring. The running order will update automatically as dogs are checked in, when they run, etc. You can stay in your set-up and keep an eye on the running order to see when you are due up. This will keep groups of people from congregating around the gate and help with social distancing. Open and Novice people can see what classes are running to have a better idea how the show is running. Go to http://dogagility.info/agility_gate to download the app and instructions on how to use it. You can download the app before you get the code. Each night the maps will be loaded into the app.

COVID 19

If you are sick or if you know that you have been exposed to COVID-19 or if you are uncomfortable with the precautions we are taking, stay home – **we will give you a full refund.**

IMPORTANT – TARPS, MATS AND CRATES

1. **WE ARE AT THE EAST END OF FREEDOM PARK (TURN RIGHT ON EUBANKS).**
2. **THIS SITE DOES NOT ALLOW TARPS AS GROUND COVERS & ALL MATS MUST BE TAKEN UP AT NIGHT. PLEASE TAKE UP YOUR MATS EVERY NIGHT FROM YOUR SET-UP AND SWITCH THE SPOT OF ALL CRATES EVERY NIGHT.**

TEMPERATURE CHECK

We will be checking temperatures each day. When you arrive, before you unpack, immediately go to the trial secretary's area to get your temperature checked. When it is checked you will be given a wristband. You will not be allowed in the ring without a wristband. **Please show your wristband to the Gate Steward before you enter the ring.**

NOTES ABOUT THE SHOW

- Masks/face coverings are required at all times, except when running your dog, when eating or when you are in your car.
- Please be aware of who is around you and practice social distancing.
- Workers! Thank you – it takes a village to put on a show!
- We will provide sanitizer for our workers and the restroom, but exhibitors need to bring their own sanitizer.
- PPE – please take any personal protection equipment you use home with you. Do not put it in the trash cans.
- Bathrooms will be supplied with sanitizer, paper towels and disinfectant in the stalls. Do not put anything in the toilets besides toilet paper! The sink will have liquid soap. Please wash your hands. The exterior door will be propped open. Please leave it that way.
- Be prepared for the show to run slower than normal.
- **PLEASE SET UP WITH 8' – 10' BETWEEN TENTS.**

HERE'S WHAT TO EXPECT:

- Crating - Set-ups are to be 8'-10' apart. There is plenty of room at Freedom Park. Help us make it as safe as possible.
- Maps - maps will be sent to you the evening before each show and will be on the website at the beginning of the judging schedule. Maps will be put on the Agility Gate app. Maps will be posted in two places at the show so you can take pictures of them. We will not have any printed maps available.
- Briefings – We will have a short briefing at the beginning of each group.
- Measuring – it is not required that you be measured.
- Walk-throughs – Further down in the judging schedule will be a list of what jump heights will walk together in each class. We expect to keep the number of people walking at one time between 20 and 25.
- Gate Steward – will be using the Agility Gate app. You can do everything on the app except move your dog around if you have multiple dogs in one jump height. The gate steward must do that at the gate.
- Ring Gates – we will have gates at this trial.
- Masks/face coverings – you can remove your mask/face covering when you are in the ring. At the end of your run, put your dog's leash on inside of the ring. We will have an area marked off outside the exit gate where you can put on your mask – **replace your mask before you leave this area!**
- Face shields – if you chose to wear a face shield, please bring a mask for going in and out of the ring as there is no way to transport your face shield from the start to the finish.
- Leashes – We will have a leash runner. You can also leave your leash on the ground at the start line and a leash runner will transport it to the ground near the finish line with a leash grabber that will be sprayed with disinfectant.
- Results – will be posted on both sides of the trailer.
- Ribbons – will not be self-serve. There will be a ribbon station at the trial secretary's table with a person handing out ribbons and labels. Please line up 6' apart to get your ribbon.

WORKERS:

All worker stations will be equipped with sanitizer, gloves, and disinfectant.

All workers must use their own chair.

Timer/ scribe, gate steward, trial secretary, judge and ribbon areas will be taped off 6' in each direction.

- Jump Setters – can choose to wear gloves or use sanitizer before they pick up and after they put down a jump bar
- Timers and scribes will sit 6' apart. Their area will be taped off so no one can get within 6' of them. Please do not bother the timer/scribe. When finished they will wipe down the timer and table with disinfectant
- Gate Stewards will have their area taped off so no one can get within 6' of them.

MOVE-UPS

All pre-show move-ups must be received **by 6 PM, Monday, November 23, 2020**. The AKC requires move-ups to be in writing. You may send an email for a move-up to stephnishimoto@gmail.com with your name, your dog's call name, the name and date of the trial and what class you want the dog moved to. If you miss the deadline for move-ups, you may move your dog up on the first day of the show for any subsequent days even if you are not showing a dog that day. A friend may do the move-up for you if you are not there. You may NOT move up the day of the show for that day.

There will be day-to-day move-ups at the show, provided the Trial Secretary receives the move-up within 15 minutes after the end of the last class. There will be no move-ups in the morning before the start of the trial.

However, a dog which has been entered in a Novice "A" class for which it is not eligible to be entered in due to class restrictions on the dog or handler, may be moved to the Novice "B" class under the following conditions:

- The request for the move must be in writing and presented to the Trial Secretary at least 30 minutes prior to the start of each trial.
- The request must state the reason and justification for the move from the Novice "A" to the Novice "B" class.

DIRECTIONS: Freedom Park EAST, 275 E. Pleasant Valley Road, Camarillo, CA 93010

From SOUTH - Take US HWY 101 North, exit Las Posas, turn LEFT onto S. Las Posas Road. Go 1 mile to Pleasant Valley Rd and turn RIGHT. Turn RIGHT on Eubanks and first left into parking lot. Parking Lot traffic is One Way.

From NORTH – Take US HWY 101 South, exit Las Posas, turn RIGHT onto S. Las Posas Road. Go 0.9 miles to Pleasant Valley Rd and turn RIGHT. Turn RIGHT on Eubanks and first left into parking lot. Parking Lot traffic is One Way.

SET-UP & SECURITY

PLEASE SET UP WITH 8' – 10' BETWEEN TENTS. Plenty of room at Freedom Park, no need to be close to each other.

Set-up is on Friday morning **at 7:00 AM**. If you would like to help unload the trailer and set up the rings, please meet the course builders at 7:00 AM.

NO TARPS ALLOWED OVERNIGHT; ALL MATS MUST BE REMOVED AT NIGHT. Please tip your crates on their side so the solid bottoms are off the grass or move them so they are not on the same spot for 24 hours. This is a wide-open park. There is no security guard -- leave things at your own risk.

MEASURING

The judge this weekend is a Volunteer Measuring Official (VMO). At this time dogs are not required to be measured. The judge will measure at her discretion.
