#### HVOC Field Rules:

1. Consumption of alcoholic beverages or smoking is not permitted on the grounds.
2. No vehicles can be driven on the grounds.
3. Any food consumed on the grounds must be monitored so no residuals are left on the grounds, and no **shelled nuts** are permitted at any time.
4. Users are permitted to use the parking area immediately adjoining the field, either paved or dirt area. The dog park parking area is not considered an approved parking area.
5. Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

### MOVE-UPS

---

All pre-show move ups must be received by 6pm, Monday, Jan 22, 2018. The AKC requires move-ups to be in writing. You may send an email for a move-up to [shelties259@gmail.com](mailto:shelties259@gmail.com) with your name, your dog's call name, the name & date of the trial and what class you want the dog to be moved to. If you miss the deadline for move-ups, you may move your dog up the first day of the show for any **subsequent** days even if you are not showing a dog that day. In addition a friend may do the move-up for you if you are not there. However you may not move up the day of the show for that day.

There will be day-to-day move-ups at the show provided the Trial Secretary receives them within 15 minutes after the end of the last class. There will be no move-ups in the morning before the start of the trial.

**However**, a dog which has been entered in a Novice "A" class for which it is not eligible to be entered in due to class restrictions on the dog or handler may be moved to the Novice "B" class under the following conditions: The request for the move must be in writing and presented to the superintendent or trial secretary at least 30 minutes prior to the start of each trial. The request must state the reason and justification for the move from the Novice "A" class to the Novice "B" class.

From CA-78 East:

CA-78 to I-15 North, exit El Norte Pkwy. Turn right on El Norte Pkwy continuing to Valley Pkwy. Turn left on Valley Pkwy. Go past

Eureka Springs and turn left at the traffic light at Beven Drive. Parking for trial will be in open field on your right.

From I-15 Southbound:

Exit El Norte Parkway. Turn left (East) onto El Norte Parkway continuing to Valley Parkway. Turn left on Valley Parkway. Go past Eureka Springs and turn left at traffic light at Beven Drive. Parking for trial will be in open field on your right.

From I-15 Northbound:

Go north for about 6 miles on Via Rancho which becomes Bear Valley Parkway continuing until it ends at Valley Parkway. Turn right onto East Valley Parkway. Go past Washington Ave/El Norte Pkwy and Eureka Springs residential area and turn left at traffic light at Beven Drive. Parking for the trial will be in open field on your right.

#### SET UP AND SECURITY:

Set up is Saturday morning! We will be unloading the trailer around 6 AM.

The field is fenced. We will not have a security guard, leave belongings at your own risk.

**Limited RV Parking at this site.** You must be pre-registered to park overnight. **You must** contact Brenda about RV parking before the trial!

#### MEASURING:

Our judge, Geoff Teare is not a volunteer measuring official. He will be available to measure your dog for this trial before the Master/Excellent classes, Open classes and Novice classes.
