MOVE-UPS

All pre-show move ups must be received by 6pm, Monday, June 25, 2018. The AKC requires move-ups to be in writing. You may send an email for a move-up to agilesam@gmail.com with your name, your dog's call name, the name & date of the trial and what class you want the dog to be moved to. If you miss the deadline for move-ups, you may move your dog up the first day of the show for any **subsequent** days even if you are not showing a dog that day. In addition a friend may do the move-up for you if you are not there. However you may not move up the day of the show for that day.

There will be day-to-day move-ups at the show provided the Trial Secretary receives them within 15 minutes after the end of the last class. There will be no move-ups in the morning before the start of the trial.

However, a dog which has been entered in a Novice "A" class for which it is not eligible to be entered in due to class restrictions on the dog or handler may be moved to the Novice "B" class under the following conditions: The request for the move must be in writing and presented to the superintendent or trial secretary at least 30 minutes prior to the start of each trial. The request must state the reason and justification for the move from the Novice "A" class to the Novice "B" class.

DIRECTIONS to NTC Park, Preble Field, 2455 Cushing Rd. Pt. Loma

Traveling on the I-5 South: Exit Rosecrans. Turn left at Roosevelt Rd. Go three blocks and turn right on Cushing Road to park in lot on left, or turn left to park on street.

Traveling on the I-5 North: Exit Pacific Coast Hwy. Turn left on Barnett. Turn left on Truxtun through 'Liberty Station' archway. Follow Truxtun and turn left on Dewey Rd. When you reach Cushing, you will see the trial site on the field. Turn either right or left to park.

From 8 West: Rosecrans exit. At Lytton—Turn Left and take the next right on Truxtun through the 'Liberty Station' archway. Follow Truxtun and turn left on Dewey Rd. When you reach Cushing, you will see the trial site on the field. Turn either right or left to park.

From downtown San Diego and San Diego airport Harbor Drive past airport to Laning Road. Make a right on Laning. Turn right Cushing Rd. Site will be on your right.

SET UP AND SECURITY:

Set up is Saturday morning! We will be unloading the trailer around 6 AM.

We will have a security guard until midnight, leave belongings at your own risk.

NO RV Parking at this site.
