Any requests for a refund/pull must be received at least 30 minutes before the start of the first run of the day!

   PLEASE TAKE UP YOUR MATS EVERY NIGHT FROM YOUR SET-UP AND SWITCH THE SPOT OF ALL CRATES EVERY NIGHT.
- SPRINKLERS WILL BE TURNED ON FRIDAY NIGHT. DO NOT LEAVE YOUR CANOPY COVER ON YOUR EZ-UP OVERNIGHT ON FRIDAY.

#### **MOVE-UPS**

All pre-show move-ups must be received by 6 PM, Monday, January 20. The AKC requires move-ups to be in writing. You may send an email for a move-up to <a href="mailto:stephnishimoto@gmail.com">stephnishimoto@gmail.com</a> with your name, your dog's call name, the name and date of the trial and what class you want the dog to be moved to. If you miss the deadline for move-ups, you may move your dog up on the first day of the show for any subsequent days even if you are not showing a dog that day. A friend may do the move-up for you if you are not there. You may NOT move up the day of the show for that day.

There will be day-to-day move-ups at the show, provided the Trial Secretary receives the move-up within 15 minutes after the end of the last class. There will be no move-ups in the morning before the start of the trial.

However, a dog which has been entered in a Novice "A" class for which it is not eligible to be entered in due to class restrictions on the dog or handler, may be moved to the Novice "B" class under the following conditions:

- The request for the move must be in writing and presented to the superintendent or Trial Secretary at least 30 minutes prior to the start of each trial.
- The request must state the reason and justification for the move from the Novice "A" to the Novice "B" class.

From SOUTH - Take US HWY 101 North, exit Las Posas, turn LEFT onto S. Las Posas Road. Go 1 mile to Pleasant Valley Rd and turn RIGHT. Turn RIGHT on Eubanks and first left into parking lot. Parking Lot traffic is One Way.

From NORTH – Take US HWY 101 South, exit Las Posas, turn RIGHT onto S. Las Posas Road. Go 0.9 miles to Pleasant Valley Rd and turn RIGHT. Turn RIGHT on Eubanks and first left into parking lot. Parking Lot traffic is One Way.

## **SET-UP & SECURITY**

Early set-up is on Thursday afternoon AFTER 3:00 PM. If you would like to help unload the trailer and set up the rings, please meet the course builders at noon. SPRINKLERS WILL BE TURNED ON FRIDAY NIGHT – NO CANOPY COVERS ON YOUR EZ-UPS ON FRIDAY NIGHT ONLY. NO TARPS ALLOWED OVERNIGHT, ALL MATS MUST BE REMOVED AT NIGHT. This is a wide open park. There is no security guard -- leave things at your own risk.

### **MEASURING**

The judge is NOT a Volunteer Measuring Official (VMO). She will be available to measure your dog for this weekend only, before the Excellent/Master classes, before the Open classes and before the Novice classes. If you need to be measured, you MUST be measured before your first run. If you need help getting measured, come by the trial secretary table and we will be happy to help you.
