MOVE-UPS

All pre-show move ups must be received by 6pm, Monday, February 17, 2019. The AKC requires move-ups to be in writing. You may send an email for a move-up to agilesam@gmail.com with your name, your dog's call name, the name & date of the trial and what class you want the dog to be moved to. If you miss the deadline for move-ups, you may move your dog up the first day of the show for any **subsequent** days even if you are not showing a dog that day. In addition, a friend may do the move-up for you if you are not there. However, you may not move up the day of the show for that day.

There will be day-to-day move-ups at the show provided the Trial Secretary receives them within 15 minutes after the end of the last class. **There will be no move-ups in the morning before the start of the trial.**

However, a dog which has been entered in a Novice "A" class for which it is not eligible to be entered in due to class restrictions on the dog or handler may be moved to the Novice "B" class under the following conditions: The request for the move must be in writing and presented to the superintendent or trial secretary at least 30 minutes prior to the start of each trial. The request must state the reason and justification for the move from the Novice "A" class to the Novice "B" class.

Move Down: After the close of entries a dog may be moved down in its class level (i.e. Master to Excellent). The request must be in writing and submitted to the trial secretary at least 30 minutes prior to the start of the trial.

DIRECTIONS: Del Mar Fairgrounds, 2260 Jimmy Durante Blvd, Del Mar, CA 92014

From the North or South off Interstate 5 Fwy: Exit Via Del Valle and Turn West. Turn Left at Solana Beach Gate. Follow the road to the parking area - **See map below for location of the Trial Area.**

PARKING: The fairgrounds charges **\$15 per day** if you enter through Jimmy Durante Blvd. Please Note: you cannot come in and out on your parking pass. You must pay \$15.00 for EACH time you enter.

If you enter at the Solana Gate you can buy a 3 day pass that will save you money.

Handicapped Parking is available to those with proper DMV plates. Handicapped parking is to provide easy (paved) access not necessarily next to the rings.

There will be an unloading zone set up by the fairgrounds near the trial area along the main drive that will allow you to drop off your crates and then park in the exhibitor's parking lot near the clock tower.

PLEASE COME EARLY TO ALLOW TIME TO PARK YOUR CAR AND UNLOAD

SET UP AND SECURITY:

You can set up from 2:00 - 6:00 PM on Thursday. The Fairground's staff will do security on the grounds. Leave belongings at your own risk.

VIDEO TAPING:

Agility Videos 4 You will be filming all the runs at Silver Bay Kennel Club's trial. They offer videos on flash drives as well as previews. Remember to bring your flash drives with you to the show.

MEASURING:

Our judges are Volunteer Measuring Officials. They will be available to measure your dog before the T2B and FAST Classes and between the Excellent/Master Classes and between the Open and Novice Classes.
