The attached judging counts is a list of the number of competitors in each class only and not the order the classes will run. Class run order will be determined on the day of trial. **Competitor run order may change due to move ups not yet received and to accommodate those running in both scent work and agility.**

**MOVE-UPS:** Deadline for move ups is 6pm, Monday Feb 18. Please send your move-ups to [scentsecretary@gmail.com](mailto:scentsecretary@gmail.com) . There will be day-to-day move-up, provided the Trial Secretary receives your move-up form within 15 minutes after the last class of the day.

**SET-UP:** Starts at 7:30am.

You will be setting up out of your car or around your car. You may leave your belongings overnight at your own risk, as there will be no security. Please bring whatever makes you and your dog comfortable. Trial will happen rain or shine.

### **CHECK IN TIMES FOR BOTH DAYS:**

**NOVICE CHECK-IN:** 8:00am; briefing and walk-thru 8:30 am. Judges and volunteers will run first.

**ADVANCED CHECK-IN:** 11:00am; briefing and walk-thru to follow the conclusion of Novice.

**DIRECTIONS TO SHOW:** Sonoma County Fairgrounds 1350 Bennet Valley Road Santa Rosa, CA

**\$7.00 Daily Parking Fee charged by the Fairgrounds**

**From the South via US 101** - Take 101 North to Santa Rosa. Exit onto Hwy 12 towards Sonoma (east); stay in the right-hand lane and take the first--almost immediate--exit (South E St./Downtown). Go straight (Bennett Valley Road). Drive past the fairgrounds racetrack and the fair marquee; Turn right onto Brookwood Ave. At the end of Brookwood, turn right onto Allen, turns into Aston Ave. On the right will be a booth entrance for the fairgrounds. Enter and take the right side road. Go straight until you see the Lytle Cow Palace building. Parking Attendants will show you where to park.

**From the East via CA 12** - From Hwy 12, westbound, take the Downtown exit. Turn left at the stop light (Brookwood). At the end of Brookwood, turn right onto Allen, which turns into Aston Ave. Ahead on the right is a booth entrance to the fairgrounds. Enter and take the right side road. Go straight until you see the Lytle Cow Palace building. Parking Attendants will show you where to park.

There is an Agility Trial running in the covered arena at the same time. We are behind the arena. There will be signs and parking people directing you where to park for Scent Work.
